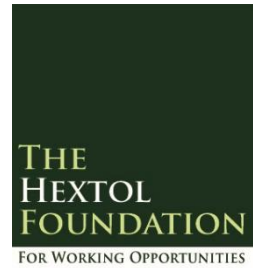


Gardening Supervisor

Job Description

Flexible – hours will depend on workload but likely to be minimum 3 days per week
£12.50 per hour



Purpose of the job

To provide a high standard gardening service to customers, whilst training and supporting teams of beneficiaries with learning differences and/or mental health needs—ensuring that quality standards and delivery deadlines are met; and beneficiaries receive coaching and support to develop their skills.

Lines of responsibility

Directly responsible to the Chief Executive.
Responsible for supervising our beneficiaries.

Main duties

- Carrying out routine gardening and grounds maintenance work, and, occasionally, specific project work, all to a high standard.
- Provide supervision, support, and guidance to beneficiaries to develop their skills and to deliver our services.
- Ensuring the work is carried out safely, and that all health & safety regulations applicable to the enterprise are met.
- Working with the Hextol CEO and the Gardening Supervisors to develop the business – developing new projects on existing sites and improving effectiveness.
- Carrying out routine administration as required.

Qualifications/experience

ESSENTIAL:

- Has horticultural knowledge and experience
- Gains a satisfactory DBS disclosure for working with vulnerable people
- Has a valid driving license

DESIRABLE:

- Has a horticultural qualification
- Has worked or lived with people with a learning disability or poor mental health, but this is not essential as training will be given
- Has experience working as part of a team

Training and Support

Part of this role requires supporting our volunteers during their shifts whilst gardening at customers' properties. It is important to note that previous experience working with people with learning difficulties and/or poor mental health is not essential, and training will be given. Our volunteers are carefully selected for their ability to be an asset to the team, usually consisting of 1- 3 volunteers.

Job share would be considered for this role.
